



## **ATHLETES ACKNOWLEDGEMENT AGREEMENT FORM**

In consideration of my selection to participate in the Jamaica Athletics Administrative Association (JAAA) Athlete's Development Fund and my willingness to accept the proposed monthly stipend of **\$60,000**, I hereby acknowledge agree and advise as follows:-

- 1 I will complete and sign the **Athlete Registration Form** and return it to the JAAA.
- 2 I will keep the JAAA updated on my Whereabouts by supplying full details of my residential and workplace addresses, telephone contact numbers and email address. Should any of this required information change, I will inform the JAAA accordingly within one month of such change.
- 3 I will abide by the JAAA's **CODE OF CONDUCT**.
- 4 I consent and agree in particular to comply with and be bound by the IAAF Anti-Doping Rules and Regulations (Chapter 3 – Anti-Doping and Medical) as displayed on the IAAF website [www.iaaf.org/about-iaaf/documents/anti-doping](http://www.iaaf.org/about-iaaf/documents/anti-doping) and participate in JADCO's Anti-Doping education seminars/activities.
- 5 I agree to participate in the JAAA's National Championships unless my withdrawal is formally approved by the JAAA
- 6 I agree that if selected for the national team I will make myself available to participate in all competitions including NACAC, CAC, PANAM, COMMONWEALTH, WORLD CHAMPIONSHIPS and OLYMPIC GAMES.
- 7 My earnings from competing in Athletics Events (athletes related activities) are less than US\$40,000 per annum or the equivalent thereof
- 8 I am not in possession of any professional contract / contracts of US\$40,000 , per annum or more than the equivalent thereof
- 9 I will provide training, medical and general progress reports and updates to the JAAA on a quarterly basis (January 31, 2016; April 30, 2016 & July 31, 2016)
- 10 I will endeavour to attend all JAAA functions or meetings to which I have been invited. These include, award ceremonies, presentation ceremonies and sponsors presentations for the JAAA events

This agreement shall be governed in accordance with the JAAA's Rules and Regulations and the Laws of Jamaica. I acknowledge that, by signing this acknowledgement and agreement, I have read and understand this acknowledgement and agreement and that it is legally binding.

I understand and fully agree that false declaration or failure to advise the JAAA of any material change or changes that subsequently ensue shall result in suspension from the JAAA ATHLETES' DEVELOPMENT FUND.
